## FLORIDA HISTORY CORNER

I would like to dedicate this month's Florida History Corner to Mr. Duke, who passed away last month. He always liked to tell stories about the old days in Archer, and one story I especially remember was the one about Ma Barker's gang buying gas at Mr. Duke's gas station (now Archer Automotive) a few days before their famous shootout with the FBI.

It was January of 1935. Doc Barker, Ma Barker's older son, was arrested by the FBI in New York City. When they searched his apartment, they found a map of Florida with a circle drawn around Marion County. So the FBI headed to Marion County in search of the rest of the gang.

One FBI agent overheard gossip in an Ocala barbershop about a group of fishermen who were renting a large house on Lake Weir. The barber said they had come in for haircuts and tipped him \$50. That

would be a very large tip today, but in those days, during the Depression, it was a great deal of money, not the kind of tip an ordinary citizen could afford.

The FBI went to the house on Lake Weir, and an agent knocked on the door, pretending to be selling magazine subscriptions. He saw high-powered rifles inside the house. Ma and Fred Barker and their partner in crime, Paul Karpis, were very friendly and invited the young man to go fishing with them. The young agent was able to recognize Fred Barker by his tattoo. Karpis left for a trip to Miami that evening.

The next morning the FBI surrounded the house and ordered Fred Barker to come out. He opened fire on them and the agents barely escaped with their lives. Gunfire was exchanged between Ma and Fred Barker and the FBI for several hours. Finally, the Barkers stopped shooting. Agents found Fred dead with eleven bullet wounds. He was still clutching a machine gun. Ma Barker was shot three times, once through the heart.

Meanwhile, Doc Barker was sent to Alcatraz. When he tried to escape, he was gunned down by prison guards. His last words were, "I'm all shot to hell!" *M. Zander*
