- Reported on the request to ask the Florida League of Cities for a second opinion concerning an appointment made to a committee by the mayor in the context to the City's Charter.
- Introduced Clay Martin, the newest member of Folds & Walker legal team. Mr. Martin has a wealth of experience in governmental issues.
