I. DISCUSSION ON POTENTIAL RECREATION AND CONSERVATION PROJECTS

Interim City Manager Glanzer stated that there is an effort by the County Commission to place on the November ballot a half-cent sales tax for a period of eight years to fund recreation and conservation projects. The County Commission has requested comment on the referendum language and for the city to come back with a list of proposed projects of how the allotted funds would be utilize. Interim City Manager Glanzer read the following list of items he put together for consideration and discussion:

Recreation:

1. Repair pavilion roof at Wilson Robinson Park.
2. Repair Fences at Wilson Robinson Park.
3. Repair and grade fields at both Wilson Robinson Park and Maddox Park.
4. Sandblast and paint pavilion at Maddox Park.
5. Install Wi-Fi at all city recreation sites.
6. Repair Caboose at Wilson Robinson Park.
7. Install lights and timer at both Pavilions.
8. Convert Racquetball courts into closed structures.
9. Upgrade old fire station, paint, AC/Heat, doors, etc.
10. Fix plumbing in the kitchen in Community Center

Conservation of lands

1. Storm water project in Holly Hills and/or Park Street.

The Commission discussed adding the following items to the list:

- Acquiring abandoned railroad property to extend the trail.
- Maddox Park directional entry sign.
- Resolve sinkhole issues.
- Indoor recreation facility.
